Adjustment of Privacy Settings for Škoda vehicles

Thank you for using our service "Fleet Interface Data". In order to activate data transmission from Škoda vehicles into your company internal fleet management systems, manual adjustments in privacy settings in your vehicle's infotainment might be needed to complete the fleet-in process. This document provides a step-by-step guide for the service setup to initiate the data flow.

Please note, that if no changes have been made to the default privacy settings in your vehicle's infotainment, no further adjustments are necessary for the fleet-in process.

Please make sure to follow the steps as described:

- Register vehicle for the service "Fleet Interface Data" via the system API (please find more information in our development guide chapter 4 "Use Cases", sub chapter 4.2 "Vehicle Registration" in our customer portal).
- Check vehicle registration within Fleet Interface via the end point "Vehicle Registration" (please find more information in our development guide chapter 4 "Use Cases", sub chapter 4.2 "Vehicle Registration" in our customer portal).
- After completed registration: In most of the cases, no adjustments to privacy settings are needed. In case the current privacy settings differs from default settings, a manual selection of privacy settings "Share my position" in the vehicle infotainment is required, as described on the following pages.



Important Notice:

Please register your vehicles first via the Fleet Interface Data and check the actual registration status before selecting the Privacy Settings in the respective vehicle infotainment manually.














