Adjustment of Privacy Settings for all Audi vehicles

Thank you for using our service „Fleet Interface“. The Audi factory settings allow data transmission into your company internal fleet management systems. Privacy settings may be checked and adjusted manually in your vehicles' HMI. This document provides a step-by-step instructions for checking and manually adjusting vehicle privacy settings.

Please make sure to follow the steps as described:

- 1 Register vehicle for the service "Fleet Interface" via the system API (please find more information in our development guide chapter 4 "Use Cases", sub chapter 4.2 "Vehicle Registration") in our customer portal.
- 2 Check vehicle registration within Fleet Interface via the end point "Vehicle Registration" (please find more information in our development guide chapter 4 "Use Cases", sub chapter 4.2 "Vehicle Registration") in our customer portal.
- 3 After completed registration: view and adjust privacy settings "Share vehicle Location" in vehicle HMI using the guide on the following pages.

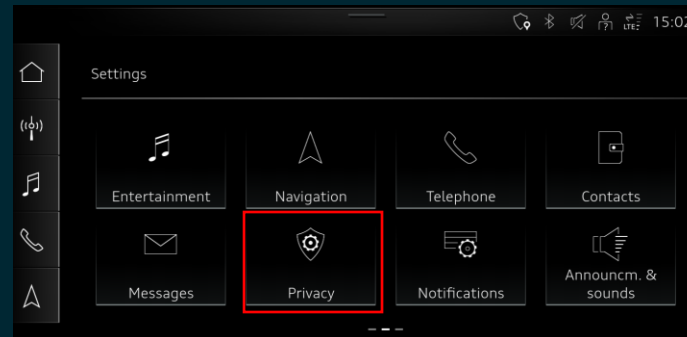

Step 1



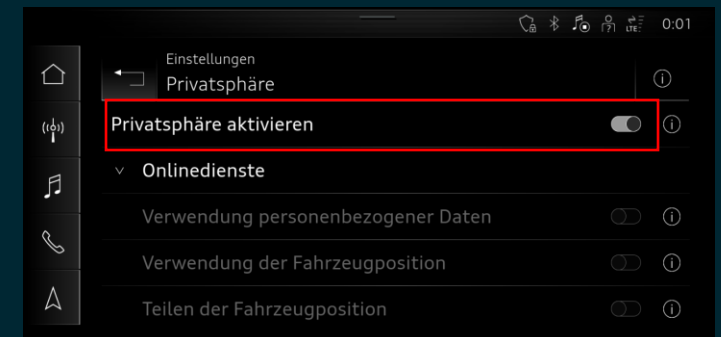
In the main menu of your vehicle, swipe through the menu until you find the settings tile ("Einstell."). Select the Settings ("Einstell.") icon.

Step 3

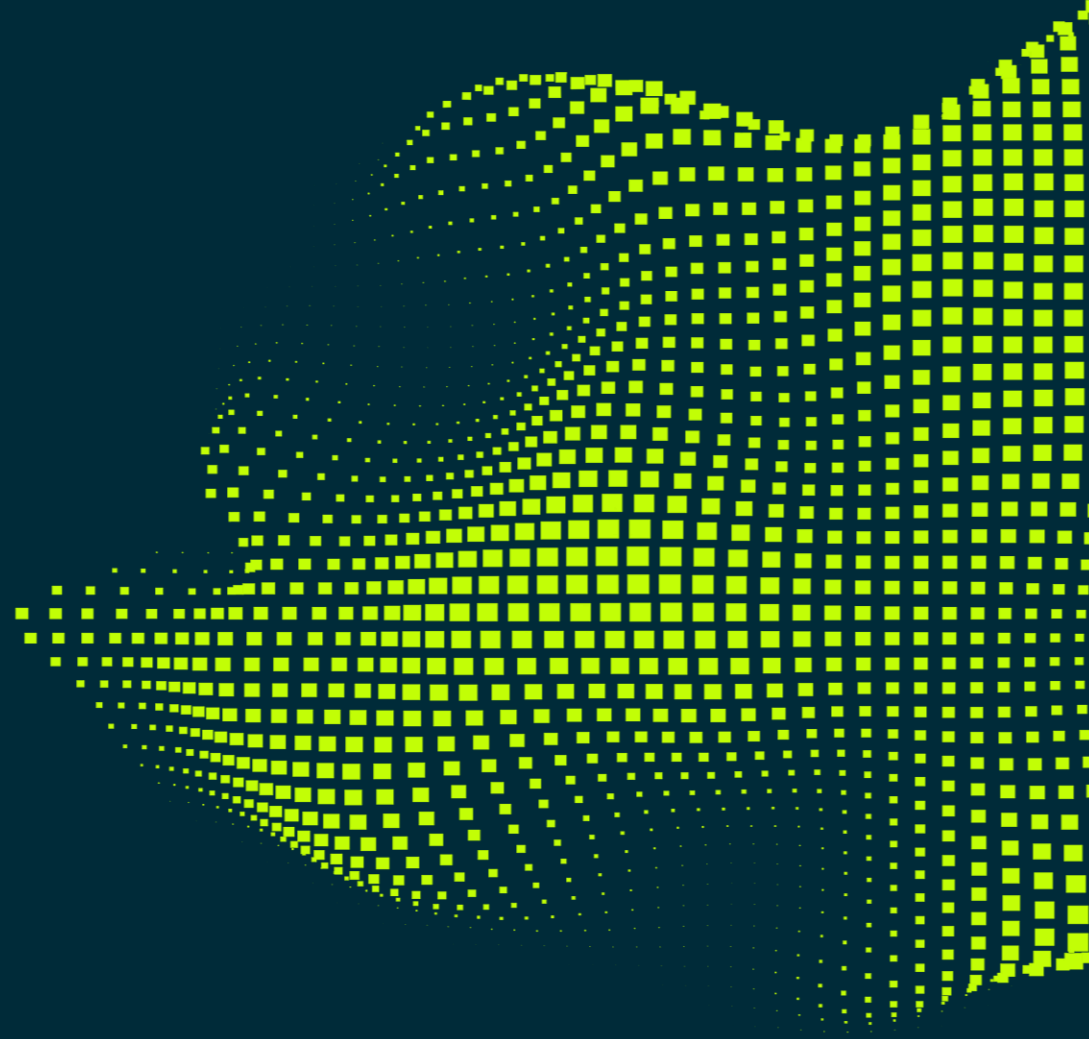

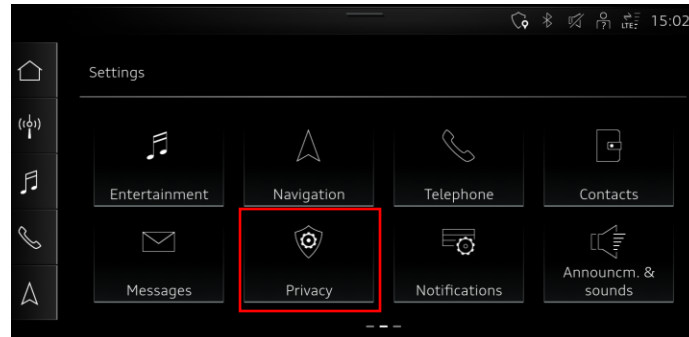

Step 1



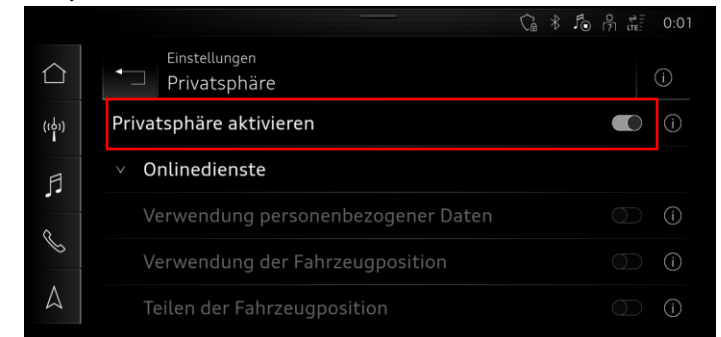
